<b>6. Profile of the Organisation</b> Biju Patnaik National Steel Institute (BPNSI), constituted by Ministry of Steel, Government of India was registered as a society in 2001 for the development of Steel Sector with an emphasis on the Secondary Steel Sector. The Institute has adopted a three pronged approach, namely Education & Training, Research & Development, and Consultancy to boost the steel sector. The Institute creates trained man power with the requisite skill set and also re-skills and upgrades the skills of the existing manpower in the steel sector. To cater to these varying needs of the Industry, the Institute while offering diploma level courses, also offers Short Term Courses. Within a short span of its existence since its inception, it has established a noteworthy ability of producing trained manpower as reflected by 70% placement of its students. Beside academics, the Institute fosters higher & more efficient production of steel by providing technical consultancy to the steel plants for implementing <i>Energy Efficient Manufacturing Processes</i> .		
<b>7. Job Description and Responsibilities</b> The Director as the Principal Executive officer shall be responsible for the proper administration of the affairs and funds of the BPNSI and shall report to the Board headed by the Chairperson BPNSI. He/She shall be vested with such executive and administrative powers of the BPNSI as may be necessary or incidental for the purpose.		
<b>8. Eligibility Conditions:</b> (i) Serving Officers from Public Sectors Undertakings/Organizations with minimum 3 years' service in the pay scale of E-6 and above. (ii) Retired Officers from Public Sectors Undertakings/Organizations served for minimum 3 years in pay scale of E-7 and above. (iii) Candidate from private sector should have at least 20(Twenty) years' experience at Executive level in Metallurgical industry as Technologist/R&D/ Management expert/ Industrial expert of National / International repute. (iv) Candidate from academia should have at least 20(Twenty) years teaching experience in IITs/NITs/ reputed institute as associate professor or professor in subjects related to Mechanical/metallurgy/material science field.		

**9. Educational qualification**

Bachelor Degree in Metallurgical/Mechanical/Electrical Engineering or Material Science from a recognized University.

**10. Experience**

Candidate should be well conversant with the problems and prospects of the Iron & steel Industry.

Preference would be given to person having experience as Head of the Department / Division of an organization either in steel industry or any other metal industry. The person should have a track record of collaboration with different institutes/ organizations of repute and have demonstrated leadership in promoting development and adoption of technology/innovation for continuous improvement.

**11. Age:** Applicant should have completed minimum 45 years of age but less than 62 years as on 5<sup>th</sup> December 2022(Application closing date)

**12. PERIOD OF APPOINTMENT**

The Director of the Institute shall be appointed by the Board for a period of five years (one year probation period + 4 years) at a time. Such Director shall be eligible for reappointment for one or more terms of three years each at a time to be decided by the Board subject to the maximum age limit of 65 years.

**13. Mode of appointment**

The position is open to all and people working with private or public sector or Government organizations or quasi government organizations are eligible to apply.
